
Addison County: Motion to approve, Grand Isle County seconded to approved. MOTION CARRIED.

### **Approval of Treasurer's Report**

November 2022 - 2nd month of the budget season (or 17%)



Membership - Year over Year chart created- Season so far the numbers from 2022 are more aligned with 2020 membership income vs 2021 membership which was \$184,664 more at this time (November)

- Income for the month was \$398,321 of which \$360,223 was from membership
- Expense a steady 7% of the budget for the past three years. \$94,924 in monthly expenses 14k in Online TMA CC Fees, \$1905 membership forms/decals, \$5k in Tradeshows/PR Mrktg related expenses, \$8511 in Trail Signage, \$7510 Cost Share/GMNF

### TMA Report - Cindy

To date there are 16,776 2023 TMAs sold vs 18,693 2022 TMAs sold year to date, a difference of 1,917. VAST saw a significant increase in TMA sales last week, maybe contributed to the weather.

### Trails Outdoor Recreation Economic Impact Study, Cindy

The funds are in a reserves account with the last study completed in 2001.

Cindy inquired if there's interest in an economic impact study.

Annually VAST adds an average of \$10K to the reserves account for an Economic Impact Study, with \$70k currently in the reserve account.

Average cost for the study is \$80-\$100k

BOD agreed there is no interest at this time for an updated Economic Impact Study.
