Lamoille County moved, and Rutland County seconded, to approve the agenda as presented. MOTION CARRIED


# **SECRETARY'S REPORT**

Motion Action Items:

- 1. Express in written correspondence to the VAST office why they would like to come out of Not Good Standing Status.
- 2. Present a management Plan to the Biard of Directors at a VAST BOD Zoom meeting. Come to the BOD meeting and outline your plans to move forward.
- 3. Complete the 2025 Grooming analysis and their log sheets.
- 4. These requests of the clubs have to be completed by September 1, 2025 to be considered to be put back in good standing.
- E.A.S.T- Ed Taube, President from E.A.S.T and Rutland County Director, Mike Stewart were on the
  meeting. They presented that the Log sheets have been completed and sent to the office. The
  Grooming Analysis is finished, and the Management plan was read and presented to the BOD. Both
  will be sent to the Office before September 1, 2025.

Essex County Makes a motion, Lamoille County seconded to put E.A.S.T. back in good Standing provided they submit the Grooming analysis and management plan to the Office prior to September 1, 2025. MOTION CARRIED.

- 2. B.E.S.T.- Rutland County Director Mike Stewart explained he has tried every form of communication with this club. Poultney and E.A.S.T. clubs will be cut off if B.E.S.T. is no longer a club. Rutland County to have a meeting in September to have President Patty to attend and come up with a Plan B, with the possibility of shifting trails to other clubs. There are about 9 miles of concern with this area. No action by the Board was taken- club remains in Not Good Standing status.
- 3. Guilford- Peter Noble and Chris Wasserlin on the meeting from this club. The Grooming logs and analysis have been submitted. A letter from Peter was sent in and gone over for the board, and he will take responsibility to be compliant in the future. Don Raginski was also on the meeting from Vernon, whom will be cut off if Guilford is Not in Good Standing. He is willing to help provide support as well. All four action items were met.

Lamoille County makes a motion, Essex seconded to put the Guilford Pitstoppers back in Good Standing. MOTION CARRIED.

#### **NEW BUSINESS**

1. Loan Guarantee for Green Mountain Roamers/ Topsham Ridge Runners.

Green Mountain Roamers are requesting a loan guarantee for \$20,000 over 5 years, with an annual payment of \$5,450 for a 1999 Piston Bully. Lamoille County makes a motion, Essex County seconded to approve the loan guarantee to the Green Mountain Roamers. MOTION CARRIED. With Washington County abstaining.

Topsham Ridge Runners are requesting a loan guarantee for \$23,327.62 over 4 years, with an annual payment of \$7,523 for a Trail Paver Drag. Essex County makes a motion, Lamoille seconded to approve the loan guarantee to the Topsham Ridge Runners. MOTION CARRIED. With Orange County abstaining.

A few dealers are set to attend the annual meeting. There will be a Vintage Groomer and some Vintage sleds coming as well. Meeting to be held at Addison County Field Days venue.
