- Budget projections and began 2022 budget discussions
- Two follow up meetings have been scheduled for the Finance Committee; June 9th and June 10th meeting for Directors offered – BOD optional meeting – review and education of budget

Approval of Treasurer's Report

Patty Companik gave a report of the financials as of May 31, 2021.

- 8 months into the budget or 67% of the budget season
- <u>Membership through May 2021</u> is 114% of budget or \$343,510 more than expected/set budget
- Income through May 2021
- Includes membership revenue is \$133,842 short of budget or 96% of expected income
- Membership is up, but overall the total income is at 96%
- Expense thru May 2021
- Monthly activity of \$483,436, of which \$425,759 was for grooming
- Expenses for the season as of May \$2,043,344 or 73% of expense budget has been utilized

Committee and Other Meeting Reports

Northeast Chapter and USA - Pat Poulin

- NEC Annual meeting was on June 21, 2021
- NY is going for a registration increase for non-residents; bringing the price closer to NH's cost.
- ISC for 2022 will be held in Dubuque, Iowa in early June
- All states and provinces were seeing significant increases in off trail riding. Quebec may lose large section of trails due to off trail riding
- The RTP Bill in US Congress is still alive, but not moving very fast. This bill would significantly increase the funding for trails across the county
- USNF are requiring engineered plans for trail bridges and possibly all trails. NH is moving quickly to complete several projects
- NEC re-elected Gary Broderick (NY) as Chair and Kim Bergeron (NH) as Co-Chair. Vermont's own Jeff Fay was elected as Secretary/Treasurer.
- Long-time (30+ years) Executive Director of New Brunswick Snowmobile Federation, Ross Antworth, will be retiring as of June 30, 2021. He will be sorely missed.

<u> Trails Conservancy – Jim Hill</u>

- We had to do a survey on some property we own in Jeffersonville. There was a washout and we wanted to make sure its within our easement. Ken has been working on this.
- Stan Choiniere Large landowner, 2,000 acres, they are clear cutting. The owners have a buyer for the land. We suggested an easement and they are willing to listen (Chester area).
- Pat Poulin Years ago we asked the board and if we were financially able to help with easements (?). This may be the year to do it.
- Jim Hill will call a VSTC meeting to discuss

Awards & Nominating – Patty Companik

- Committee has met and award selections are complete
- Awards, groomer jacket, pins, etc., have been ordered, pick up in August
- Speeches and other administrative items are currently being worked on

- Pat Poulin This is covered by the Law Enforcement through VAST
- Cindy Locke Divided equally among 3 pots, Public Safety, Wardens and Sheriffs/police. That is the money that is used to coordinate patrols
- Registration money comes from the state not VAST

<u>Miscellaneous</u>

- Doug Jacobs asked for clarification on who can vote/make motions.
- Cindy Locke responded that when the County Director is present, only the County Director can vote/make motions. Alternates are considered guests when the Director is present.
