# NEW BUSINESS

### Board Retreat

Discussion regarding a BOD retreat prior to Annual Meeting in Killington, Friday evening – Sunday morning dates of 8/5-8/7 & 8/26-8/28 were suggested. Cindy to follow up with Jeff and Mark regarding if alternate directors would be permitted to attend in the director's place, or just added in general.

Lifetime Membership – Doug Jacobs

Discussion of Lifetime Membership for Dennis Lemire presented by Doug Jacobs.

# Unanimous BOD vote needed: Chittenden County: Motion to approve, Lamoille County seconded to approve as presented. MOTION CARRIED.

Doug Jacobs shared Patty Companik was voted in to become the next Windsor <mark>C</mark>ounty president this fall.

# Funding from State of Vermont discussion – Cindy Locke

Most of VAST funding has been restored. The budget was going to go to Governor last week and hasn't, once it does, he has 5 business days to sign or just let it pass. No reason at this time to think that he'll veto. In conference committee's understanding is that the stipulations have been removed so we are waiting for it to get to the administration. Cindy will update the BOD in June.

## FY2022 Budget/Actual EOY Projection – Cindy Locke

I will be presenting budget verses actuals with end of year projections at every meeting until the end of the season, a copy is included in BOD packet. Projected that we will end the year in the black in both the General & Trails Funds. Beginning to build the 2023 budgets very soon for BOD to review in June and vote in July.

New reserve line item for VAST club equipment was added for this year as a reserve account to build up funds to help clubs with equipment vs the standard pot of trail money. This will actually be something that's a VAST reserve account dedicated specifically to assisting clubs and won't be used from emergency reserves. The plan is to use it sparingly to supplement the existing program.

Discussion on the VAST building account and condition of VAST building. Cindy mentioned building is in good condition, may consider patching or resurfacing the driveway. Work done recently include roof repair, side yard excavation and new retaining wall, sealing the foundation and flood repair and mitigation.

VAST trucks have been on a 5-year rotation, Toyota is a 2016 and this fall would be considered for rotation.

Discussion on emergency vs. disaster and how to determine when appropriate to use each.

Reserve accounts will be voted on at the September BOD meeting.

### Resource Committee Presentation - Ivor, Ellis, Perry

Ivor shared an introduction and process of the Resource Committee per Tim Mills creation of the committee.

Year-long project regarding recommendations that would provide a positive nonbiased impact with quick implementation to the clubs. Their recommendations are a direct reflection of what they heard from all of the directors and club volunteer representatives. Grooming miles discussed in the presentation represent corridor miles only.

Presentation covered and overview on:

- Grooming and maintenance
- Membership & club dues
- Membership a club's "membership" does not correlate to number of miles maintained and groomed
- Increasing club dues doesn't correlate directly to the club for the trails they groom
  Some clubs have same milage of trails but have a significant difference in membership based on size of the club
- Membership grooming miles
- Putting more money into membership is not fair to most of the clubs and the overall VAST trail system
- Some clubs have more resources and support to recruit and build their membership
- Grooming cost estimates

- o Grooming rates have not increased since 2015
- Need to focus on trails and health of our clubs
- Proposed TMA increase option to help to make a positive change would need \$400k additional income resulting in a \$20 TMA increase
- Option 1: \$20 TMA increase/\$400k = \$3 rate increase avg per mile across all classes
- Option 2: \$30 or \$40 increase to provide \$800k additional income to assist with grooming contracts
- With all money going towards grooming miles and contracts
- Option 3: \$40 increase
- \$20/grooming \$20/equipment grant
- Equipment grant increase by \$400k
- Eliminate "over cap" payments
- Idea of grooming contracts beginning based on snow depth, help to preserve equipment and maintenance
- If groomed prior to the grooming contract start, the club would be financially responsible
- Additional funds from any version of TMA increase not used in grooming rates
- If we exceed \$20k any excess would be presented to BOD to vote on where to allocate
- Resource committee recommendation for a \$20 TMA increase
- Options Summary \$20 TMA increase all for grooming rate increases (\$3 avg across all classes)

Trails Working Group Update - Matt, Jeff & Brian

- Trying to create policy language and to help with moving towards a motion
- Trails working group is created with individuals from a variety clubs based on location, size & grooming miles
- Focusing on equipment grants and providing support to clubs
- Reviewing the grooming financial analysis and taking into consideration increases with fuel costs
- Reviewing on how payments are made and looking at a possible reconfiguration possibly with a bank of milage for their grooming contract
- Working towards finetuning verbiage for potential policy to bring to trails committee
- Working on connecting with members
- Coming up with policies to help support clubs and partner together to establish funding

# Jeff reminded everyone that at the present time there is no TMA proposed increase under discussion. It was mentioned in the Resource Committee presentation. The increase is for wording on the presentation and there is nothing officially proposed for a TMA increase at the moment.

- Discussion on TMA cost and ways to help maintain and sustain the cost of the sport.
- Jeff extended an appreciation to the Resource Committee for their hard work and diligence with gathering and presenting information to the BOD.
- Discussion on trail class determination and grooming miles
- Discussion on membership, expressed hesitancy with snowfall maps determining when the grooming could begin.
- Discussion with feedback on not wanting to move forward with a TMA increase
- Discussion for increased use of trail counters to determine areas of traffic and which trails are utilized the most by the club to help determine funds.
- Discussion on possibly having clubs manage their own grooming funds accordingly with parameters and guidelines on spending may assist with reducing the confusion with current grooming contracts?
- Discussion on grooming caps, milage and grooming contracts.
- Discussion on grooming equipment and ways to maintain and preserve equipment.

- Mark Reaves reminded us that the information is provided based on research from the Resource Committee. There isn't support at this time to increase TMAs and the proposed budget will be presented at the annual meeting for a vote.
- Discussion on the difference between VT from NH, NY and ME. We are funded differently, as we are a self-funded association.
- Discussion on variances with the consolidation of some clubs and equipment and how it may affect volunteers
- Discussion on policies as two separate things between fuel increases and overall cost of living increase.
- Hoping to have updates to the Trails Committee from the Work Group for the May 31st meeting
- Email questions to Matt or Jeff which will shared with the Work Group and Trails Committee.
